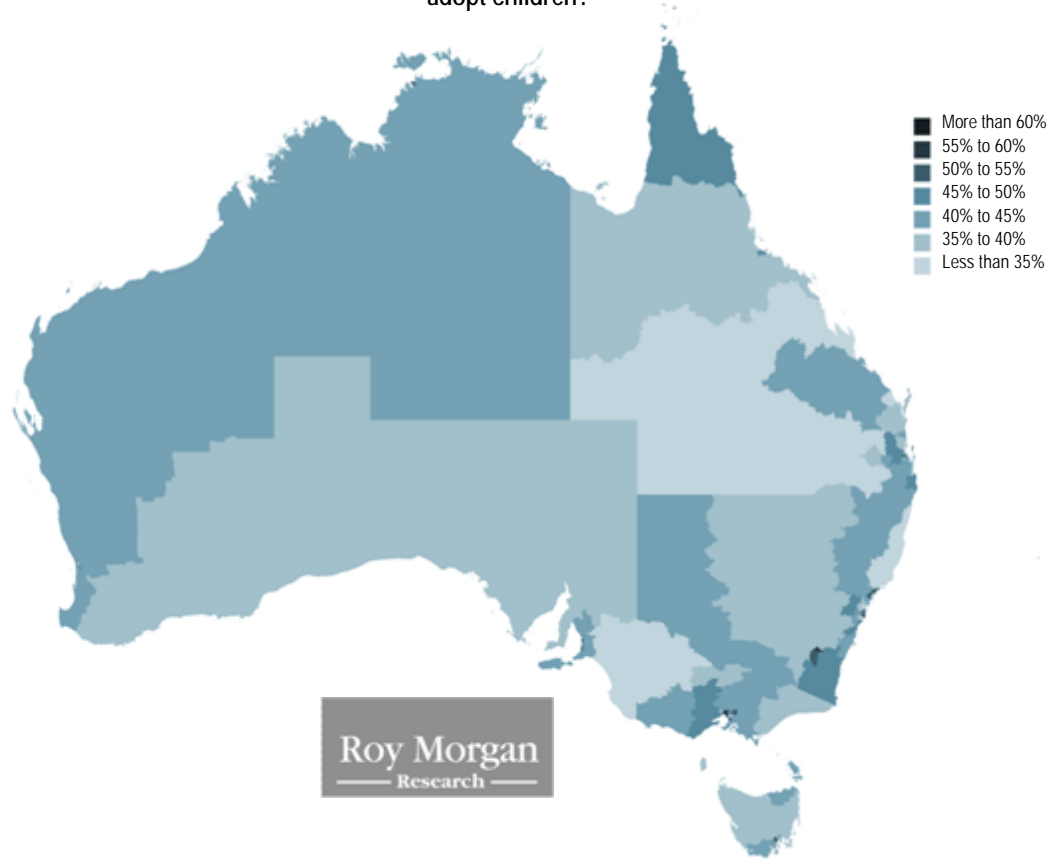


# HOMOSEXUAL COUPLES SHOULD BE ALLOWED TO ADOPT CHILDREN
